## **NOTIFICATION-9 of 2023**

Sub:-Enrolment of Nurses (who are working outside india) in Nurse Registration and Tracking System (NRTS) portal.

Attention of all Nurses who are working overseas and qualified in india and registered with various State Nursing Registeration Councils in India is invited. The Guidelines and Gazette Notification (https://www.indiannursingcouncil.org/uploads/pdf/15997401506310.pdf) and(https://www.indiannursingcouncil.org/uploads/pdf/15996349648642785725f587e14722dd.p df) related to NRTS issued by Indian Nursing Council. Most of the Nurses who are working overseas have already enrolled. For the purpose of maintenance and operation of the Indian Nurses Live Register mandated to be maintained by the Council as per Section 15-A of the Indian Nurising Council Act (1947), the Nurses Registration and Tracking System (NRTS) has been developed after extensive consultations with all the SNRCs. It has standardised forms for collection of the data of Registered Nurse and Registered Midwife (RN & RM)/ Registered Auxiliary Nurse Midwife (RANM)/Registered Lady Health Visitor (RLHV) upon Aadhar based biometric authentication. Adoption of a common system and formats by all the SNRCs is a pre-requisite for the maintenance of the Live Indian Nurses Register. Atfer verification of data, each Nurses will be issued a Nurse Unique Identity Number on top of RN/RM number issued by SNRCs. However it is observed that large number of Nurses working outside India have not yet enrolled into the NRTS portal.

To have a Live Registrer of Nurses, working in and out of India it is hereby requested that all those Indian nurses who are working outside india to enroll into NRTS with immediate effect. The URL for enrolling nurses into NRTS is placed below:-
